(through January 30, 2026 – Part B application due date)

Technical assistance and support for Early College Designation Applicants is focused primarily on professional learning sessions and targeted office hours to support applicants in the program planning and application process.

PROFESSIONAL LEARNING SESSIONS

- **Tuesday, November 4 - 9:00-10:00 a.m. - PLC Session – “Rooting Your Program: Application Overview and Equitable Access”** - In this session, we will explore the Part B application, required uploads, organization, and logistics. We will also introduce P2C’s closed Learning Hub for Part B applicants, where all documents, templates, and coaching materials will be housed.
- **Tuesday, December 2 – 9:00-10:00 a.m. – “Cultivating Growth: Part B Coaching Kick-off”** - P2C is excited to offer additional support with prescriptive, partnership-specific coaching services as you complete the Part B Early College Designation application. Join us to meet the coaches and learn more about the structure of Part B coaching services.
- **Tuesday, November 18 – 9:00-10:00 a.m. - PLC Session – “Necessary Groundwork: Curriculum Alignment and On-ramping Students.”** This session will focus on aligning curriculum and preparing students for college coursework success and how to demonstrate your planning in the Part B application.
- **Tuesday, December 16 – 9:00-10:00 a.m. - PLC Session – “Staking Your Program: Schedules and Student Support ”** - In this session, we will examine strategies for developing student schedules that incorporate all required components, including student support.
- **Tuesday, January 13 – 9:00-10:00 a.m. - PLC Session – “Fertilizing and Watering Your Program: Effective Partnerships in Early College”** – This week, our attention turns to the required components for your partnership’s MOU and how to nurture a strong, collaborative partnership.
- **Tuesday, January 20 – 9:00-10:00 a.m. - PLC Session – “Rooted, Rising, and Ready to Submit Your Part B Application”** - Join us for final tips, ideas, and strategies for successfully completing and submitting your Part B application.
